License/Certification Renewals

All license and card renewal forms, received by our Division, have been processed. Licenses and cards are required to be renewed by June 30th every year. Renewal forms are sometimes returned and marked as undeliverable. Licensees and certified applicators are required to notify the Division of address changes within 10 days. In addition to address changes, some renewals may get lost in the mail.

If you have not renewed your license, certified applicator, or registered technician cards, you should contact the Division immediately. Licensees who fail to renew, and continue to work after the expiration date of their license, are in violation of the Structural Pest Control Law. If your license is placed on inactive status, you must still renew each year, and maintain your recertification status, by taking the appropriate number of CCU's. Licensees on inactive status are not sent a license certificate, but will receive a letter indicating that the license has been renewed. The last date that licenses and certified applicator cards can be renewed, without having to take the exam again, is December 31st.

If you do not receive a letter, after renewal of an inactive license, you should contact the Division, well before December 31st, to ensure that the renewal has been processed.

New Email Address for Sending COI

When it is time to send in an original or updated certificate of insurance, you can now have it emailed directly to insurance@ncagr.gov. This address will get the insurance information to the appropriate people, who handle getting your insurance information updated in your account. Please let your insurance company know about this new email address the next time you are due to have yours updated with the Division.

Delay of Effective Date for EPA Rules

As many of you may be aware, the EPA is revising the Federal Certification of Pesticide Applicator Rules. There are two major revisions that would affect Structural Pest Control Applicators: 1) The minimum age requirement for persons using restricted use pesticides would change to at least 18 years old and 2) The requirement for annual pesticide safety training for Noncertified Applicators that would include training on safety, application, personal protection, and pesticide labeling. The Environmental Protection Agency has delayed the effective date for these and other revisions to the Certification of Pesticide Applicators Rule (40 CFR 171) until May 22, 2018. Stay tuned.... we will keep you updated as the effective date gets closer.

Registered Technician School Registration

When filling out an Application to enroll in a Registered Technician School, please fill in the block on the "Registered Technician School – APPLICATION FOR ENROLLMENT" form that asks for "Fax No. and/or Company Email Address." This information is often left blank. Some companies still use fax, as well as e-mail, and both are requested and preferred. Having both is especially helpful, when an employee submits a registration for an RT School, close to the date of the school. Additionally, the application has a space for two (2) mailing addresses, one that is the physical location, as well as a US Postal Service address. Having both is ideal.

Please remember, when mailing checks or money orders, to detach and keep the check stub, for your records.

Checking Credit Status

Sometimes it is difficult to determine whether the 3 out of 5 year, or 4 out of 5-year requirement is being met, to meet recertification. A change has been made to the online transcript database, to try to make it easier when checking CCU credits. When checking your record, there will be a color change between the fiscal years. In the example below, the color changes from gray to blue green, to gray, to blue green. Each of these color changes represent a year of earning credits. This example shows the licensee has 4 out of the 5 years needed to satisfy the number of years that credits are needed.



Bug Humor




- Q. What does a spider do when he gets angry?

Spider Facts

Settlement Agreements

The NC Structural Pest Control Committee approved the following settlement agreements on July 27, 2017:

- (Guilford) Jeffrey D. Brewster, owner of Royal T. Pest Control in Greensboro, agreed to pay \$800 for performing household pest control services during a two-month lapse in liability insurance. Royal T. Pest Control performed \$8,049 in services during the lapse.
- (Mecklenburg) Solomon Airhart, doing business as Aruza Pest Control in Charlotte, agreed to pay \$2,000 for performing structural pest control work without a license. Aruza advertised his services through various websites, including Facebook, Google+, Groupon and Instagram. It is unlawful to advertise, offer, engage in or supervise any phase of structural pest control work without a license. Airhart had 41 accounts while operating without a license.
- (Rutherford) Kim Allan King, certified applicator for Lakeside Mills in Spindale, agreed to pay \$1,200 for improper handling of pesticides. A fumigation treatment of exterior grain bins inadvertently entered an area with another registered technician through a connecting overhead pipe. This resulted in hospitalization of the technician due to exposure to aluminum phosphide.
- (Rutherford) David D. Purcell, structural pest control license holder for Douglas Pest Control in Forest City, agreed to pay \$400 for performing three household pest control services with an expired license. Purcell's license expired June 30, 2016, and was renewed July 19, 2016.
