

Completed initial inspection at facility today. Inadequacies to address include; 1) Cover/Remove exposed wood and materials not impervious to moisture in cat display room including doors/windows/and frames (0202,0204), 2) Repair/Replace 2 damaged dog houses (0201), 3) Remove 2 wooden dog houses from outdoor enclosures (0204, 4) Cover/Remove exposed wood and materials not impervious to moisture in Leonard building. These 4 items should be corrected within 60 days. Wooden deck in outdoor puppy enclosure is not currently in use. Board will review options and discuss decision with inspector prior to use.
