Narrative Explanation

New inspection performed. As of now the County government of Guilford County is overseeing the shelter. The improvements made here have made a huge difference. There was no odor present throughout the facility during our inspection. The cleanliness has improved tremendously. All of the dogs have been removed from the laundry room. The kennels in this area are being used for storage, therefore the area is much more sanitary. All of the cat areas are less cluttered. Many of the wire crates have been removed allowing to have more space and better ventilation to flow through. Dog enclosures were clean and dry before the animals were put back into them after being cleaned.

The following items need to be addressed:

- 1) (0203) The walls of the outside enclosures need to be repainted as the paint is chipping.
- 2) (0204) In kennel #55 metal piece at bottom of kennel has sharp jagged edges and needs to be cut off smooth.
- 3) (0203 & 204) Fence patrol needs to be done. Repair fencing on the bottom of the gates that has come loose at the bottom.
- 4) (0204) Kennel walls of G Hall need to be painted as paint is chipping.

Overall the shelter has greatly improved. There were no signs of illness/injury in the general population. The staff appeared less stressed and happy to be here. The working conditions have and will continue to improve with the changes being made. Facility is ready to be licensed once the application is approved (maximum numbers need to be adjusted).
