### Herbicides (Pesticide) Licensing

For a person to prescribe herbicide use or apply herbicide on another's property, they must be licensed by the state of North Carolina. The N. C.

Department of Agriculture and Consumer Services Pesticide Section and the N.C. Pesticide Board manage the licensine process. If you are receiving cost-share assistance for the herbicide treatment, the N.C. Forest Service must review and approve the HAP prior to the herbicide work being performed. Landowners are also responsible for returning completed HAP to their Forester for cost share reimbursement.
