Upon request by the North Carolina Department of Agriculture and Consumer Services (NCDA&CS), it shall be my responsibility to produce such records in a timely manner. I understand and agree that the burden of proving that each tagged animal meets all requirements of the program shall solely be borne by me. In the event that I cannot conclusively prove to the satisfaction of NCDA&CS that animals tagged with the "Got to Be NC Livestock" tag meet all requirements of the program, NCDA&CS may, in its sole discretion, take any action it deems necessary at law or in equity. Such action may result in, but shall not be limited to, any of the following: revocation of membership, disqualification from competition, loss of premiums, awards, or auction proceeds. I understand that any exhibitor, their immediate family and any other party involved in violating this or any other provision of the program, or involved in the unethical fitting and showing of an animal, will be barred from exhibiting or showing at the N.C. State Fair, or any other event sanctioned by the NC Department of Agriculture, and will forfeit all premiums, prize monies and awards won in any division.
