

SUPERVISOR FAILURE TO ATTEND

02 NCAC 59A .0301(c) requires District boards to notify the Commission in writing of any member that has failed to attend three consecutive meetings, except when prevented by illness. Notification from the District shall include an explanation for non-attendance and the actions that the District board has taken to address the Supervisor's attendance.

Since the November Commission meeting, two districts have reported lack of attendance by Supervisors:

CUMBERLAND SWCD

Monique McMillan has missed six consecutive meetings since May 2024. At the time of the report, the Cumberland SWCD had not been able to contact her but have since obtained new contact information. The Division recommends sending Supervisor McMillan to the Inquiry Committee established under 02 NCAC 59A .0302 for consideration.

PITT SWCD

David Collier had missed four consecutive meetings since May 2024 due to work constraints. Mr. Collier did not seek re-election and his term expired in December 2024. No further action is recommended.
