

Animal and Crop Foreign Disease Prevention VISITOR WAIVER

The responsibility for knowledge and implementation of the following procedures prior to the visitation of a research facility is that of the visitor and the host individual or institution. Each visitor and host are asked to sign this waiver and verify that the restrictive waiting period has been met and that the personal decontamination procedures have been followed. The station superintendent has the right to deny access to anyone deemed not to be in compliance with our restrictions.

We welcome you to this NC Department of Agriculture and Consumer Services/NC State University/NC Agricultural and Technical State University agricultural research facility. We appreciate your interest in our ongoing work and are committed to sharing our many accomplishments; however, the responsibility for the protection of our crop and livestock assets is the duty of not only station personnel, but of visiting institutions and individuals as well.

In an effort to guarantee maximum accessibility to this research station/research farm, while ensuring the safety and health of state agricultural assets, **we ask that you carefully read and agree to the following by witness of your signature at the end of this document.** Your assistance is imperative to the continued success of our research program.

I UNDERSTAND AND AGREE TO THE FOLLOWING:

1) Restrictive Waiting Period After Traveling Outside of the Continental United States:
 In the event that I have recently traveled outside of the continental U.S., **A FULL 72 HOURS HAVE PASSED** since the day of my arrival in the U.S. Proximity to agricultural interests abroad is not of consequence to this restriction.

2) Personal Decontamination Procedures:
 Contingent on Item 1 (above), I have followed proper decontamination procedures **prior to my arrival at this Research Station facility** as outlined below which are crucial in protecting the research facility's livestock, plants, and crops —

- Since my arrival to the U.S., my clothing has been freshly laundered or was not previously exposed to agricultural facilities outside of the U.S.;
- My footwear has been properly decontaminated (scrubbed with soap and water and cleaned of all dirt and debris) **OFF** the visitation site or has not been worn on agricultural facilities outside of the U.S.;
- I have showered with soap and shampoo; and
- I have cleared and cleansed my nasal passages.
